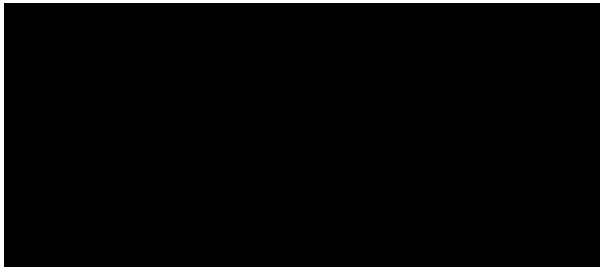

Re Official Information Request – Climate change documents

I refer to your official information request of 28 February 2019 for the following information:

Copies of all reports, memos, discussion papers, advice, plans, or policies created by your DHB (including contractors) since 1 January 2017 concerning climate change.

The request was later clarified on Wednesday 6 March 2019 to notify that you are seeking documents in which climate change is either the *'primary topic or a major topic, rather than where it is referenced tangentially.'*
